<i>Meatball Mix (20053311)</i>	10.0	1	0	0.454
<i>Cold Water / Ice</i>	15.0	1	8	0.680
<b>Total</b>	<b>100.0</b>	<b>10</b>	<b>0</b>	<b>4.54</b>

*Method – Using a mixer or by hand*

- 1. Mince the meat through a coarse plate, place in mixer or mixing bowl*
- 2. Add meatball mix and blend together.*
- 3. Gradually add water and mix in until absorbed.*
- 4. Re-mince through a 5mm plate.*
- 5. Form into burgers of the desired weight size and shape*

*Note:-*

- Mincing the meat through a coarser plate with result in a coarse burger.*
- Temperatures after processing should not exceed 5°C*
