Method A – using a mixer

1. Mince the meat twice and place in mixer.

2. Add sausage mix and mix well, to evenly distribute, until the mix is sticky.

3. Gradually add water and mix in until absorbed.

4. Fill out the sausage meat into the required size skins.

Note:

- Mincing the meat through a coarser plate will result in a coarser textured sausage.
- Temperature after processing should not exceed 5°c.

FILLING:

The sausage meat can be filled into hog, sheep or collagen casings and link as desired.
